Maha court arants Rahul Gandhi permanent exemption from appearance in defamation case

A court in Maharashtra's Thane district on Saturday granted a permanent exemption to Congress leader Rahul Gandhi



from appearing before it in a defamation case filed against him by a Rashtriya Sawyamsevak Sangh (RSS) functionary.

Bhiwandi First Class Judicial Magistrate C Wadikar who

heard Gandhi's application filed through his counsel Narayan Iyer observed that the Congress leader deserves a permanent exemption. The magistrate also set June 3 for recording evidence in the defamation suit filed by local RSS worker Rajesh Kunte. Kunte had in 2014 filed a private complaint before the Bhiwandi magistrate's court after watching Gandhi's speech where he allegedly accused the RSS of Mahatma Gandhi's assassination. Kunte claimed this statement slandered the reputation of the RSS.

Gandhi had appeared before the court in June 2018 and pleaded not guilty.

"Accused Rahul Rajiv Gandhi is hereby exempted from appearance in the court till the further order passed by the court subject to following conditions," reads the order, a copy of which was accessed

"Accused to undertake that his duly designated advocate punctually and regularly appears before court on each and every scheduled date and conduct the trial in absence of the accused," says one of the conditions. "Accused to remain present in court as and when directed," reads another.

Rahul Gandhi, who was recently disqualified as an MP after his conviction by a Surat court in a defamation case, had last year sought exemption from appearance in the Bhiwandi court on the grounds that he was a Delhi resident and a Lok Sabha member who had to visit his constituency (Wayanad), attend party work and travel a lot. Gandhi had requested that whenever required, he be allowed to be represented by his lawyer in the hearing. Kunte recently argued that since Gandhi is no longer a parliamentarian, he should not be given an exemption in the matter. The Surat court had on March 23 sentenced Gandhi to two years in jail in a 2019 criminal defamation case filed against him over his "why all thieves have Modi surname" remarks. The court also granted him bail and suspended the sentence for 30 days to allow him to appeal in a higher court. The next day, he was disqualified as a member of the Lok Sabha.

2019 Pulwama attack 'Why were CRPF personnel denied aircraft' Congress asks Centre

The Congress on Saturday demanded answers from the Centre on the outcome of the probe into the 2019 Pulwama incident in which 40 CRPF jawans were killed, asking why the CRPF personnel denied aircraft and were made to commute via road despite the terror attack threat. Congress general secretary Jairam Ramesh accused the BJP-led Union government of "minimum governance and maximum silence" and asked it to comment on the reported revelations made by former Jammu and Kashmir Governor Satypal Malik on the incident.

"The government believes in the principle of minimum governance and maximum silence ... It is the government's responsibility to answer

questions raised by the opposition," he said, adding that the Congress will continue to raise questions on the issue that concerns national security.



Addressing a joint press conference along with party leaders Pawan Khera and Supriya Shrinate, he said the government has created buildings as symbols of democracy but democracy is missing.

"Vishwaguru has created a new model

of democracy where there are symbols and buildings of democracy but the soil of democracy is now missing," he said. Shrinate asked, "Why were the CRPF personnel denied an aircraft? Why were they not airlifted?"

"Why were the Jaish threats ignored? Why were 11 intelligence inputs, between 2 January, 2019 and 13 February, 2019 that had warned of a terror attack ignored," she said and asked, how militants procured 300 kgs of RDX.

"After a period of over four years, where has the inquiry in the Pulwama terror attack reached? Where, when, how and who will fix the accountability for NSA Shri Ajit Doval and then Home Minister Shri Rajnath Singh," she asked.

Shivraj Says Cong CM Candidate Chosen On Basis Of 'Huge Wealth'

Madhya Pradesh Chief Minister on the basis of wealth and resources, Shivraj Singh Chouhan on Saturday said the Congress chooses Kamal Nath as its chief ministerial face in the state on the basis of his "huge wealth". Even Congress leaders endorse this view, Chouhan told reporters here. Reacting to the barb, Nath, a former chief minister, dared him to name any "company or industry" he (Nath) owns.

'He has airplanes, helicopters, cars, property, wealth, that is why he is a Congress leader and their chief ministerial candidate.... But we have the public (on our side)," the chief minister said without naming the state Congress chief.

even Congress leaders say that he is a leader because he has "huge wealth", Chouhan claimed.

"If a leader of Congress is decided misrepresented his statement.

then let them....but this cannot be a vardstick for a leader in democracy.' he said.

Asked about the chief minister's remarks, Nath said, "Shivraj Singh ji will not desist from speaking lies. Will he be able to state that I have no link to any industry? I am not the owner of any industry or company." Chouhan can not digest his food without lying, the Congress leader said, adding that the chief minister should name the "company, industry or business I own".

Earlier, a newspaper report had quoted Congress's Rajya Sabha member Vivek Tankha as describing Nath as a (financially) capable person, 'as required in politics'. Tankha on Saturday said the newspaper

Crisis-hit Pakistan government set to hike petrol price for next fortnight

Pakistan raised prices of petrol and gas by a massive 113 percent to a historic high in a bid to secure the critical International Monetary Fund (IMF) loan tranche. Petrol prices have been jacked up by Rs 22.20 per litre in a bid to appease the IMF for reviving the \$7 billion extended fund facility (EFF). Gas prices have been hiked from 16 per cent to 113 per cent for different sectors including domestic consumers, according to a recent Pakistan Oil and Gas Regulatory Authority (OGRA) notification.

After this hike, petrol cost PKR 272 per litre whereas highspeed diesel (HSD) will sell for PKR 280 per litre in the cashstrapped nation. Kerosene and light diesel oil, on the other hand, will sell for PKR 202.73 per litre and PKR 196.68 per litre respectively. The hike in petrol and gas prices came into effect on February 16 Petrol and gas price hikes were one of the preconditions of the IMF coupled with the new fiscal measures undertaken through the 'mini-budget'. Inflation is expected to rise in Pakistan after the petrol price rise and the mini-budget. The mini-budget is aimed at reducing the budget deficit and broadening the government's tax collection net. The increase comes after the Economic Coordination Committee (ECC) of the Federal Cabinet approved the summary for hiking the gas price by 112 per cent for domestic

consumers, classified into 12 categories of protected and unprotected consumers, on February 13. The Federal Board of Revenue (FBR) issued an SRO which led to an increase in the standard 17 per cent general sales tax (GST) to 18 per cent to raise \$639 million in extra revenue during the fiscal year ending in July this year. Commenting on this development, head of research at a local

brokerage Ismail Iqbal Securities Fahad Rauf was quoted as saying by news agency Reuters, "It's unfortunate that we only know how to increase indirect taxation, and burden the existing taxpayers." He added, "On the other hand, there is no income tax collection from retailers, real estate, and agriculture segments."

LAWS TO PROTECT **WOMEN RIGHTS IN INDIA**

THE PROHIBITION OF CHILD **MARRIAGE ACT OF 2006:**

Studies have shown that India ranks 13 among that nation which has high child marriage rates. Girls before becoming eighteen are forced to marry and at times a man way too older. This Act was enacted in 2007. This Act states that the minimum marriage age for a girl is eighteen and for a boy is twenty – one. Parents and relatives who force their child to marry as a child will face the punishment mentioned in this Act.

SPECIAL MARRIAGE ACT OF 1954:

The main aim of this Act is to put in place certain kinds of marriages. In our nation with many religions and ethnicities it is hard to put in place laws and provisions for all of them. Therefore, they tend to follow the provisions mentioned in the

Special marriage Act. However, this law is not applicable to the Land of Jammu and Kashmir.

DOWRY PROHIBITION ACT OF 1961:

This Act simply states that giving and taking of dowry is a crime and offenders will be punished severely. Even though dowry has been banned and made illegal, issues relating to this still persists. Women are being beaten up, tortured etc because their family cannot meet the dowry demands of the in – laws house. This is a very challenging issue and needs the utmost care and this Act must be put to full use.

INDIAN DIVORCE ACT OF 1969:

This Act simply lays the processes and procedures for getting a divorce. This has also laid various provisions which deals with the advantages that a woman can obtain after the divorce. Family courts have been established to hear and deal with such

MATERNITY BENEFIT ACT OF 1861:

This Act puts forth the provisions for the employment of female workers and the benefits during maternity that has been compulsorily given by the law. This lays down laws and rules with respect to the leave during maternity, extra allowance, hospital needs, breaks for nursing etc.

MEDICAL TERMINATION OF PREGNANCY ACT OF 1971:

This Act has been amended twice in the

years 1975 and 2002. The main purpose and aim of this Act are to control the abortions that happen illegally. This Act has put forth that only valid and qualified people will be allowed to conduct the abortions.

SEXUAL HARASSMENT OF WOMEN AT WORKPLACE ACT OF 2013:

The main three ingredients of this Act are Prevention, Prohibition and Redressal. This Act aims to make sure that women have a safe and secure environment in their work place. The sexual bullying at work place also includes verbal tones which has sexual tones, invading a female worker's private space, Unconsented inappropriate touches etc. You can take guidance from start while handling the POSH complaint in your organization.

INDECENT REPRESENTATION OF **WOMEN ACT OF 1986:**

This Act lays down the provision for the prohibition of portraying women in any indecent obscene manner in any form of publications such as Ads, prints, writings etc.

NATIONAL COMMISSION FOR **WOMEN ACT OF 1990:**

This has been established by the NCW which is a governmental body. This Act aims to provide women all over India with voice and power to speak up about their issues and problems. This Act aims to

Processing of Complaints

To provide adequate relief to the complainant and ensure suitable redressal of her grievances. The complaints are acted upon in the following manner

Investigations by the police are expedited and monitored

Family disputes are resolved or compromised through counseling or hearing before the Commission.. For serious crimes, the Commission constitutes an Inquiry Committee which makes spot enquiries, examines various witnesses, collects evidence and submits the report with recommendations. Such investigations help in providing immediate relief and justice to the victims of violence and atrocities. The implementation of the report is monitored by the NCW. There is a provision for having experts/ lawyers on these committees.

A few complaints are also forwarded to the respective State Commissions for Women and other forums like the National Human Rights Commission, National Commission for Scheduled Caste / Scheduled Tribe, etc., for disposal of the complaints at their end.zn respect of complaints related to sexual harassment of women at their workplaces, the concerned organizations or departments are urged to constitute an Internal Complaints Committee(ICC) as per the mandatory provisions Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 in order to enquire into such complaints. The Commission regularly monitors and takes up these complaints with the concerned organizations/departments to expedite the disposal of the complaints by following the statutory provisions.

War against Wires-The saga of overhead networks

The Brihanmumbai Municipal Corporation precautions. The Central Electricity Act, (BMC) from time to time has initiated action to remove overhead dangling unauthorised cable wires. These wires can pose a threat to human life such as death or electrocution. In the past too, when such wire networks have collapsed on bridges and tracks, they have led to closure of the tracks, stations and roads.

The BMC has several rules and policies in place to curb this menace. Such wires are supposed to be laid underground and not overhead. On such rules not being followed, a query can be posed to the ward officer who will then look into the matter. BMC's Draft Development Plan 2034 prohibits overhead electric wires except in exceptional circumstances like fire

2010 also has provisions for maintenance of such overhead wire networks. However, Cable Television Networks Regulation Act, 1995 states that any cable operator, may establish cables under, over, along, across, in or upon any immovable property under the control of a public authority but the catch here is that such networks should be authorised and maintained. A possible solution can be for BMC to provide ducts to lay out the wires.

We can act as responsible Mumbaikars and report to our ward officers if there are any unauthorised, poorly maintained or unsightly wires noticed to improve our safety as well as our city's aesthetic.

Co-operative societies cannot deny entry to single women, people belonging to certain communities, as per Hon'ble Supreme Court. It further observed that housing societies are violating the Fundamental Rights of women by denying them and imposing restrictions and not letting single women occupy flats which is impermissible and cant tolerate this attitude from societies The Society has been classified as a "service provider" under the Consumer Protection Act, which has been reinforced by several judgments of the Consumer Courts. The sole-responsibility of the society is to provide "common services and facilities" to its members, which also legally means "common services and facilities". Articles 14 and 15 of the Indian Constitution provide for equality before law. Discrimination on the grounds of religion, race, sex, place of birth or any of these is prohibited under this section. Every citizen and non-citizen of India, as per the Constitution of India, is provided with the fundamental right to reside (resident) anywhere in India, except in restricted and restricted areas.

Infact section 73-BBB reserves seats on committees of societies for woman members and elections thereto. Article 14 states the right to equality for all the citizens of India, still women have to constantly fight for their rights for the decisions they take. Article 21 covers in depth the various inner aspects of the right to life, namely right to

privacy and the freedom to make one's choices. But patriarchy has blinded society to such a great extent that despite the introduction of new amendments or their existence in the Constitution, they cannot digest the fact that women also constitute a major part of the population and equally have the freedom of choice to make informed decisions about their life. Society tends to create a nuisance for small issues which involve women making independent decisions and so gender has taken the form of a massive concern.

If they are of the opposite sex people assume at once that the woman is running a brothel and then she will be 'slut-shamed' and inflicted restrictions upon. India's rising Covid cases: Experts say common cold-like spread suggests endemicity, urge precaution

of the SARS-CoV-2 virus moving infection is unknown. into an endemic state in India and behaving like other coronaviruses that cause common cold-like symptoms and can keep reinfecting, say scientists.

According to the Union Health Ministry on Friday, India recorded 6,050 fresh coronavirus cases, the highest in 203 days, with 28,303 active cases. The death toll has increased to 5,30,943 (over 5.3 lakh) with 14 new fatalities while the daily positivity rate has been recorded at 3.39 per cent. The surge is being attributed to a new COVID-19 subvariant, XBB.1.16, which has been circulating through India for the last few months.

"At the present time, there are only about 800 sequences of XBB.1.16 from 22 countries. Most of the sequences are from India and in India XBB.1.16 has replaced the Immunologist Satyajit Rath added other variants that are in circulation.

"Most of the infections are mild and are treated on an outpatient basis." He said the need for hospital admissions in view of severe Covid infection is seen among the elderly and those with immunocompromised conditions. "Currently, COVID-19 infections are mild, with predominantly upper respiratory tract symptoms like sore throat, running nose, fever, and body aches. In patients requiring admission, cough, breathlessness, and fall in oxygen saturation are seen in most," the doctor explained.
